

(CEU). Her professional focus is on nuclear diplomacy, including international organizations and regimes in nonproliferation, nuclear risk reduction, nuclear security, arms control, and disarmament. She is a certified PRINCE2 project manager with extensive experience in international educational event and conference management, eager to improve and innovate.

Valeriia was a visiting researcher at the James Martin Center for Nonproliferation Studies (CNS), a consultant at the World Institute for Nuclear Security (WINS), and an intern at the Division of Concepts and Planning at the International Atomic Energy Agency (IAEA) Department of Safeguards and Carnegie Endowment for International Peace (CEIP). Valeriia is a Fulbright scholar and obtained her Master's degree in Nonproliferation and International Security from the University of Georgia (USA) and has a Bachelor's and a Master's in International Relations from Odesa I.I. Mechnykov National University (Ukraine).
